

SUMMARY ANNUAL REPORT
OHIO BRICKLAYERS LOCAL NO. 8 SECURITY PLAN
May 31, 2011

TO PARTICIPANTS OF THE PLAN - This is a summary of the annual report for Ohio Bricklayers Local No. 8 Security Plan, EIN #52-2101436, Plan number 002 for the period June 1, 2010 to May 31, 2011. The annual report has been filed with the Pension and Welfare Benefits Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT - Benefits under the plan are provided by a Trust. Total plan expenses were \$322,906. These expenses include \$280,301 in benefits paid to participants and beneficiaries and \$42,605 in administrative expenses. A total of 1,061 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$3,908,078 as of May 31, 2011, compared to \$3,410,822 as of June 1, 2010. During the plan year, the plan experienced an increase in its net assets of \$497,256. This increase includes unrealized appreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$820,162 including employer contributions of \$341,241, and net earnings from investments of \$478,921.

YOUR RIGHTS TO ADDITIONAL INFORMATION - You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report.

1. An accountants' report.
2. Financial information and information on payments to service providers.
3. Schedule of assets (held at end of year).
4. Schedule of reportable transactions in excess of 5% of the current value of plan assets.

The charge to cover copying costs will be \$.25 per page.

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan, 33 Fitch Boulevard, Austintown, Ohio 44515, and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
