Dear Mahoning & Trumbull County Building Trades Member:

As you know, your good health is always a priority for Envision and Mahoning & Trumbull County Building Trades. That is why you are receiving this valuable coupon for Prilosec OTC for the treatment for frequent heartburn (heartburn two or more days a week). The Mahoning & Trumbull County Building Trades and Envision are sending you this coupon because it has been found Prilosec OTC is an effective treatment for heartburn.

Starting August 1, 2007 your formulary will no longer cover Aciphex, Prevacid, Nexium and Protonix unless you have previously tried and failed Prilosec OTC or Omeprazole as a prescription benefit. You must have been on Prilosec OTC or Omeprazole by your physician writing a prescription for it **and have had that prescription processed at your pharmacy by using your pharmacy prescription card.** If you have tried and failed Prilosec OTC or Omeprazole, and you require one of these drugs, you will then pay the Tier 3 copay if your prescription history with Envision shows that you have utilized Prilosec OTC or Omeprazole as a prescription benefit in the past.

You may use the enclosed coupon to purchase a free 14 count trial dose without a prescription from your local pharmacy if you and your doctor determine Prilosec OTC may be an appropriate therapy for you. After the trial dose, you will need to have your doctor write a new prescription specifically for Prilosec OTC and present this prescription to your pharmacist so you may obtain future supplies through your Envision/Rx Options pharmacy plan for a **\$0.00 copay.**

Prilosec OTC is indicated only for the treatment of frequent heartburn for adults 18 years of age or older. Please read the drug facts and product labeling before taking it to ensure that this product is appropriate for you. If you have any questions or condition other than frequent heartburn, please consult your doctor before taking this medication. Your doctor can tell you if Prilosec OTC is right for you. Please note the information contained in this letter you are receiving is provided for educational purposes only. You are not required to change medications but if you continue to use Nexium, Aciphex, Prevacid or Protonix without first utilizing Prilosec OTC or Omeprazole you will be required to pay 100% of the cost of these drugs. As always, decisions regarding your care is your responsibility and that of your physician. Talk to your doctor before beginning any new treatment for frequent heartburn or discontinuing any prescription drug.

We would also like to remind you that your prescription benefit is a Mandatory Generic Program. If you elect to receive a brand name prescription when there is a generic available you will be charged the difference between the cost of the generic and brand name drugs in addition to the brand name copay
